## Passenger Handling and Cabin Surveillance

- Special Categories of Passengers
- Able Bodied passengers by unsupervised exits
- Safe stowage of baggage and cabin service items
- · Cabin and galley secure checks
- Silent Review
- Recognition and management of drunks/drugs/ aggressive passengers
- Live animals in the cabin

- Re-fuelling with passengers onboard
- In flight checks cabin surveillance including DG practical CBTA exercise
- Duties in turbulence and securing the cabin
- Motivation of passengers and crowd control in emergency evacuations

#### All Normal and Emergency Procedures including

- Incident and Occurrence Review
- Accident Review
- Provision of safety information through passenger briefing and safety demonstration
- Non pressurisation, slow and sudden decompression, hypoxia, donning of portable oxygen equipment by each crew member
- Land and water evacuation
- Other in-flight emergencies including in-flight fire drill, emergency cabin preparation
- Recognition of unusable exit
- Pilot Incapacitation including use of a checklist for Cabin Crew

#### Passenger handling and crowd control

- Generic verbal commands
- Marshalling passengers away from the aircraft
- Evacuation of SCPs with emphasis on PRMs
- Authority/responsibility for evacuation and other emergency procedures



# Instruction on the use of safety and emergency equipment (relevant to a/c type)

- Life jacket donning and practical handling of Infant life jackets and floatation cots (if applicable)
- Handling of Fire extinguishers and PBE donning
- Communication equipment, megaphones, crash axe, torches
- Slide raft, life rafts, survival packs and their contents
- Pyrotechnics
- Other portable safety equipment

### The following topics should be covered by the operator:

- Aviation Terminology
- Theory of Flight
- Seat allocation mass and balance
- FTL and rest requirements
- Communication techniques, common language, and terminology
- Instruction on the location and use of all types of exits\*
- Drills and Oxygen systems relevant to each aircraft type/variant
- The location and removal of Safety and Emergency equipment relevant to aircraft type.
- \* OWE practical training can be carried out at TGT (triennial)
